# **MAR Annual and Regional Meetings**

The MAR Board of Directors, due to the COVID-19 pandemic, have canceled the 2021 MAR Annual Meeting. This decision, although disappointing, is the correct decision to ensure the health and safety of MAR members.

MAR will, like 2020, include the 2021-2022 proposed budget and the nominees for Board Vice President and Treasurer in the Spring MAR Newsletter. Members will be able to vote by phone or Survey Monkey on these issues. More information will be provided in the Spring MAR Newsletter.

MAR is hopeful that the COVID-19 vaccination roll-out will continue in a positive direction and by fall 2021, MAR will be able to hold Regional Meetings. Members are encouraged to contact the MAR Office with any questions or concerns.

# **2020 MAR Informational Meeting Follow-up**

In the fall of 2020, MAR held seventeen (17) Informational Meetings across Maine. MAR collected the members questions from those meetings and developed a podcast with the answers to the questions. ## **COVID-19 Pandemic and Vaccinations**

As Maine continues the COVID-19 vaccination roll-out, let us take a moment to appreciate the excellent work of Maine's public service employees, medical professionals, private agencies and all of the organizations and individuals who continue to work to advance the health and safety of all of us.

Waiting for the ability to pre-register for the COVID-19 vaccine or for a notification of a vaccine appointment can be nerve racking---it has been a long year.

However, looking for the positive helps to reduce the anxiety. Maine has over 225,000 Mainers over the age of 65. This is a monumental task to schedule all of us at many different locations. Even with the challenges, Maine continues to make progress. As of 3/1/2021, Maine has administered:

349,840 vaccine doses 228,274 first doses 121,566 final doses

In addition to the number of vaccines administered, Maine continues to expand the vaccination locations. Currently there are 55 sites and 24 pharmacies.

If you are having difficulty finding a vaccine site or need help pre-registering, contact MAR at (207) 582-1960 and we will help you.

**Please Note:** When going in to receive the COVID-19 vaccine, you should bring your health insurance medical ID card (Aetna Medicare Advantage, Anthem Medicare Preferred, or Health Trust Group Companion Plan) and your Social Security Medicare card (red/white/blue card). The federal Center for Medicare Services (CMS) is paying for the vaccine – requiring your Medicare card.

Remember for each person vaccinated, your risk is reduced for getting COVID-19.

#### **MAR Legislative Committee**

As of February 24th, MAR's Legislative Committee is following 45 bills pending in the 130th Maine Legislature. Among those 45 bills, MAR is actively taking a position on the ones listed below:

**LD 84 An Act To Increase the State Share of the Cost of Health Insurance for Retired Teachers.** This bill proposes to increase the State share of the cost of health insurance for retired teachers to 55%. This was a significant point of concern raised by retired educators at MAR's Informational Meetings. MAR is supporting the bill.

LD 99 An Act To Require the State to Divest Itself of Assets Invested in the Fossil Fuel Industry and LD 319 An Act To Promote Socially Responsible Investing by MainePERS by Prohibiting Investment in Fossil Fuel Industry or For-Profit Prisons. These bills would prohibit MainePERS from investing in fossil fuel companies as well as for-profit prisons. While MAR understands the social policy behind the proposals, we believe MainePERS should continue to exercise its fiduciary responsibility for the exclusive benefit of members of the retirement system as required by the Maine Constitution. MAR opposes both bills.

LD 117 An Act To Preserve the Health Care of University of Maine System Retirees. Recently, the University of Maine proposed to replace their existing group health insurance retiree coverage with stipends to retirees designed to enable them to purchase individual insurance. A class action lawsuit resulted in the University allowing their retirees to choose whether to stay on the group health plan or to accept a stipend. At present, LD 117 is a concept draft designed to protect health insurance coverage for University retirees. MAR expects to support the bill.

**LD 136 An Act To Increase the Maximum Pension Deduction for State Income Tax.** This bill proposes to increase the maximum annual Maine State income tax pension deduction for non-military retirement pensions from \$10,000 to \$35,000 over a 5 year period. MAR is supporting this bill.

LD 290 An Act To Stabilize Property Taxes for Individuals 65 Years of Age or Older Who Own a Homestead for at Least 10 years. This bill requires municipalities to maintain the property tax on the homestead at the amount billed in the year prior to application for stabilization. MAR supports this bill.

LD 323 An Act Regarding Insurance Coverage for Telehealth Services and LD 333 An Act Regarding Telehealth. These bills make changes to the provisions governing health insurance coverage for telehealth services. MAR supports both bills. **LD 341 An Act To Address the Windfall Elimination Provision**. This bill is a concept draft. The Windfall Elimination Provision (WEP) has been an issue for many years for public service retirees. However, the WEP is a condition of federal law and repeated efforts to change this law have been unsuccessful. MAR has spoken to the sponsor of this bill, Senator Trey Stewart, and we will continue to monitor it closely.

### **HEALTH INSURANCE NEWS**

**Long-Term Care Services** – These services can be provided in a nursing home, assisted living facility, etc. and may include medical care, therapy, personal care and homemaker services. Aetna's Medicare Advantage Plan for state retirees; Anthem Medicare Preferred (PPO) With Senior Rx Plus for educator retirees; and the Health Trust Group Companion Plan for municipal retirees usually does not cover long-term care services. Medicaid will pay for nursing home care if you meet income and asset limits. **Planning for future health care needs** – Advance directives and living wills are examples of some legal documents which give instructions to your family, health care providers and others about the kind of care you want to receive if you cannot communicate your wishes. Other types of documents include health care proxies and power of attorney. You do not need a lawyer to create an advance directive, living will or health care proxy. To create a power of attorney document, you should consult a lawyer.

#### **Update - Social Security Penalties**

MAR continues to pursue the repeal of two federal laws that penalize many Maine retirees who collect both Social Security and MainePERS pension benefits. The Windfall Elimination Provision (WEP) unfairly reduces Social Security benefits for many retirees and the Government Pension Offset (GPO) reduces or eliminates the benefits received by surviving spouses of retirees. Maine is one of 13 states affected by these penalties – the states where employees contributed to pension plans but not Social Security.

MAR understands that Maine's Congressional Delegation supports the repeal of the WEP and GPO. This week, staff of Senator Angus King's Washington DC office assured us the Senator will remain an original co-sponsor of the repeal legislation when it is re-introduced in the Senate in the near future. The House version (H.R. 82 Social Security Fairness Act of 2021) was introduced in the House of Representatives on January 4, 2021.

The repeal of these Social Security provisions remains an uphill battle, mainly because support from the unaffected states is unlikely. However, MAR will continue to push for the repeal.

Any member who expects to receive Social Security benefits in the future can get an estimate of their benefits, as well as the expected penalty, by calling the Social Security Administration. As always, members with questions are welcome to call MAR for further information.

#### **Technology Corner** by Lisa Blue

During this time of year it seems we are always waiting. Waiting for Spring to arrive, for the snow to melt, for tax season to be over. No time has it been more felt than during the pandemic.

Unfortunately, one thing that has not been in a "holding pattern" is the amount of scams and robocalls. How many times have you been alerted recently your car warranty is going to expire?

One set of scams which are of utmost concern to me at the moment are the spoofing calls about COVID-19. *Spoofing* is when a caller deliberately falsifies the information transmitted to your caller ID display to disguise their identity. Scammers often use neighbor spoofing so it appears an incoming call is coming from a local number or spoof a number from a company or a government agency you may already know and trust.

The Social Security Administration and IRS have both issued warnings about scam calls concerning COVID-19 benefit payments, stimulus checks, and fake stock offers. Locally Dr. Nirev Shah of the CDC warned folks in one of his recent briefings that fraudsters are offering COVID-19 tests, HHS grants and Medicare prescription cards in exchange for personal details, including Medicare information.

So what can you do to avoid being scammed?

- Do not answer calls from unknown numbers. If you do, hang up immediately.
- If the caller or a recording offers an "opt-out" choice, you should just hang up. Scammers often use this trick to identify live potential targets.
- Do not respond to any questions, especially those that can be answered with "Yes" or "No."
- Never give out personal information such as account numbers, Social Security numbers, mother's maiden name, or other identifying information.
- If they represent themselves as being from a company or a government agency, hang up and call the phone number on your account statement, in the phone book, or on the company's website to verify.
- Talk to your phone company about call blocking tools and apps you can download to your mobile device. For more information about robocall go to fcc.gov/robocalls.

# **Federal Income Taxes**

#### April 15th will be here before you know it.

As the income tax deadlines nears, many members are looking for tax preparation assistance. The tax preparation assistance has changed during the Covid pandemic. Most tax preparation assistance is over the telephone, by mail or online with limited face-to-face interaction.

For free tax preparation assistance, there are several potential organizations with limited availability. These are local Area Agency on Aging, CA\$H Maine, AARP at 1-888-687-2277, IRS sponsored Volunteer Income Tax Assistance at 1-800-906-9887. To find free tax filing near you, call 211 or use the 211 Maine website.

For a free online tax preparation the federal IRS Free File features 10 brand name tax software providers at https://apps.irs.gov/app/freeFile/browse-all-offers.

If MAR members do not want or cannot use these options, MAR has blank paper copies of Form 1040 with instructions. You can call the MAR Office and we will send you the blank 1040 form with the instructions.

#### **No Guilt Chocolate Dessert**

Here's a recipe for fudge or chocolate cookies made with healthy black beans as the main ingredient.

You can adjust type of shortening or sweetener to your preference.

#### Ingredients:

- 1 (15 oz.) can black beans (rinsed/drained)
- 6 Tablespoon melted coconut oil or butter
- <sup>3</sup>/<sub>4</sub> cup pure cocoa powder
- 6 Tablespoon sugar, maple syrup, honey, or agave

**Options**: 1. Top with 1 pinch of sea salt or Himalayan salt

- 2. Add 4 Tablespoon chopped nuts,
- 3. Blend in 1 teaspoon mint or almond extract.

**Directions:** Combine all ingredients in blender or food processor. Form dough into greased 8 by 4 baking loaf pan or square baking dish and refrigerate. No need to bake. Let set in refrigerator for at least one hour. Keep 5-6 days or freeze as individual squares.

**Cookie version (baked)**: Add ½ cup flour and 1 egg to form cookie dough (add some water if needed for dough consistency) and bake at 350 degrees for 15 minutes or until done.

Since the Legislature convened in January, the MAR Legislative Committee with the strong support of Barbara and Diane has been tracking and commenting on bills that may have an impact on retirees. We have written letters in support of bills related to the cost of health insurance for retired teachers and the stabilization of property taxes. We are working on LD 136 which would increase the maximum pension deduction for State income tax.

The Board of Directors have been meeting each month virtually reviewing financial reports and discussing with staff MAR activities. As you probably know, Board membership includes a Regional Director for each of the five MAR regions. There are now two vacancies, Region 2—Penobscot, Piscataquis, Hancock and Washington Counties— and Region 5— Cumberland and York Counties.
